# Court Cases and the Writing of African History

#### **Course Description**

Throughout the centuries, Africans engagement with the law was broad, rich and complex. While European conceptions of law were disseminated around the world during colonial expansion, we should not simply assume that they were the exclusive or even the most important normative framework operating in colonial societies and in colonial courts. African populations' agency, their vernacular understandings of law, as well as non-European legal systems clearly played a pivotal role in the daily making of law in the continent. Court cases are privileged documents to re-construct the history of law in Africa. They allow researchers to better understand how the interaction of different historical agents shaped law and the resolution of conflicts in colonial societies. "Court Cases and the Writing of African History" introduces students to research in the field of African history using court cases. The seminar presents basic knowledge on how to work with this type of documents. In order to achieve this goal students will work with transcriptions of court cases and other legal documents. The course also focuses on how African court cases' collections are linked with broader debates on digital humanities, historical memory, and documentary heritage.
